Note: This form may take you 10 minutes to complete.

- You **do not** need to make a nomination if you wish to distribute your CPF moneys to your family members; under the intestacy laws (for non-Muslims)/Inheritance Certificate (for Muslims).
For non-Muslims,
1) If you are single, your CPF moneys will be divided equally between your parents.
2) If you are married with children, half of your CPF moneys will be given to your spouse, and the remaining half divided equally among your children.
- For Muslims, your CPF moneys will be distributed according to the Inheritance Certificate, which your family members can obtain from the Syariah Court.
- If however, you wish to distribute your CPF moneys differently, please complete sections A and B. Please note that a marriage automatically revokes your earlier nomination (if any) but a divorce does not. Additionally, a will does not supersede your earlier CPF nomination. For more information on the distribution of your CPF moneys under the intestacy laws/Inheritance Certificate and under CPF nomination, please refer to the Frequently Asked Questions at our website, www.cpf.gov.sg.
- In the event you wish to make a nomination, you will require 2 witnesses. We encourage you to complete this form before our Customer Service Officers (CSOs) at any of our Service Centres who can be your witnesses and clarify any questions you may have in respect of the nomination process.
- If however, you choose to have 2 witnesses other than our CSOs, both witnesses must be at least 21 years old and they must not be any of the nominee(s). You cannot be a witness. Please see the instructions attached for further details.
