About this booklet

This booklet contains contribution rate tables for employees who are above 65 years old.

As an employer, you are required by law to pay the employer and employee's share of CPF contributions. The employee's share of contributions may be recovered from his wages.

CPF rates

The contribution rates are as follows:

Note

- The rates in columns (2), (4), (6), and (8) represent the amounts payable by the employer in the first instance. The rates in columns (3), (5), (7), and (9) represent the amounts that are recoverable from the employee's wages.
- For employees in the above 55 to 60, above 60 to 65 and above 65 age groups, replace the figures underlined in columns (2) and (3) with the corresponding figures in columns (4) to (9).
- The contributions should be rounded off to the nearest dollar. An amount of 50 cents should be regarded as an additional dollar.
- When recovering from the employee's wages, the cents should be dropped.

How to compute CPF

Definition of Wages

CPF contributions are computed based on the employee's wages. Wages is defined as remuneration in money due or granted to an employee in respect of his employment. This includes overtime pay, allowances, cash awards, commissions and bonuses.

Classification of Wages

For the purpose of computation, wages are classified as follows:

Ordinary Wages

Ordinary Wages are wages due or granted wholly and exclusively in respect of an employee's employment in that month and payable before the due date for payment of CPF contributions for that month. This includes allowances (*see page 4 for examples of some allowances which are liable for CPF*).

Additional Wages

Additional Wages are wages which are not granted wholly and exclusively for the month. Examples are the annual bonus, leave pay, incentive and other payments made at intervals of more than a month.

Total Wages

The total amount of an employee's wages for any calendar month means the sum of his Ordinary Wages for the month and the Additional Wages paid to him in that month.

From 1 January 1990, a limit has been set on CPF contributions for additional wages of employees earning more than \$100,000 a year in total wages. For more information on how the ruling applies, please refer to the Employer's Handbook.

Computing Employer and Employee's share of CPF

When computing the employer and employee's share of CPF contributions, you should first calculate the total CPF contributions payable, then subtract the amount recoverable from the employee's wages to get the employer's share.

Common allowances and payments that attract CPF

CPF is payable for allowances and payments to employees, including:

- Acting allowance
- Anniversary cash award
- Annual wage supplement/Bonus
- Attendance allowance
- Cash incentive
- Child-care subsidy
- Commission
- Cost of living allowance
- Children's education allowance
- Extra duty allowance
- Festival allowance
- Fixed holiday allowance
- Gratuity paid to serving employees
- Grooming allowance
- Housing allowance paid directly to employee
- Laundry allowance for personal clothing
- Leave pay
- Maternity allowance
- Meal allowance given monthly in lump sums
- Overtime pay
- Probation period pay
- Productivity cash award
- Sales performance award
- Service charge
- Shift allowance
- Stand-by allowance
- Temporary lay-off benefits
- Tips
- Transport allowance paid other than for official duties

How to use the contribution rate tables

To find out how much CPF you need to pay for your employees, just:

- Determine the total wages of each employee, and
- Check out the relevant pages for the corresponding amount of contributions payable and the amount recoverable from your employees' wages, against the wages.

For example, if wages are \$550, refer to pg. 9 for the amount of contributions payable.

Separate booklets on CPF contributions for workers in the other three age groups are also available for employers who have employees in these age groups.

Calculation of CPF: Examples

Contributions for employees above 65 years

Where total wages are \$6,000 or less

The contributions can be read directly from the contribution tables.

Example 1

Ordinary Wages	:	\$ 656.50

Where total wages are more than \$6,000

Calculate the contributions as follows:

Step 1	Split Total Wages into Ordinary Wages and Additional Wages.
Step 2	Calculate the contributions for Ordinary Wages. Amount payable by employer = 8.5% of Ordinary Wages (the maximum contribution payable is \$510 on Ordinary Wages of \$6,000) Amount recoverable from employee's wages = 5% of Ordinary Wages (the maximum contribution recoverable is \$300)
Step 3	Calculate the contributions for Additional Wages. Amount payable by employer = 8.5% of Additional Wages Amount recoverable from employee's wages = 5% of Additional Wages
Step 4	Calculate total contributions.

Please refer to examples 3 and 4 to see how the contributions are calculated.

* Contributions payable by the employer should be rounded off to the nearest dollar.

When recovering contributions from employee's wages, the cents should be dropped.

Change of rate when employee moves to next age group

When an employee moves to the next age group, the contribution rate of the next age group will only apply from the first day of the month following his birthday. The example below shows the change in contribution rates for an employee moving from the 55 years and below age group to the above 55 – 60 years age group.

Example 5
